Health Guarantee

Your puppy is guaranteed to be in good health and free of any communicable disease at time of sale. Your puppy has been examined, vaccinated, and micro-chipped by a veterinarian and been given a clean bill of health. We encourage you to take the puppy to a veterinarian of your choice within 3 days of purchase for a "Well Puppy Visit" and to validate the following health guarantee. If the veterinarian does not give the dog a clean bill of health, Buyer must notify The Perfect Pup immediately. The puppy will be exchanged for another of equal value. No cash refunds. We reserve the right to have the dog re-examined by our veterinarian at our cost. Any condition that is minor, correctable or breed related minor condition is not covered. The Perfect Pup does not accept responsibility of conditions diagnosed after 3 days from the date of purchase. Heat stroke, exhaustion, dehydration, and other heat related conditions are not covered in any way. We provide a 5 year hereditary, genetic health guarantee, which is as follows. If within 1 year from the date of birth, a licensed veterinarian determines that your puppy has a hereditary, genetic defect that adversely affects the puppy's health (excluding tracheal collapse and patellar luxation since both may involve trauma or environmental issues), you will be given the following option. Puppy may be returned with original receipt and contract for another of equal value. No cash refunds. A report from the examining licensed veterinarian with the diagnosis/prognosis would be required for a replacement to take place. In the event your puppy dies from hereditary/genetic defects, a necropsy report stating the cause would be required. This guarantee is offered to the original purchaser only and is non transferable.

Buyer Responsibility

The Buyer agrees to take good care of the dog, feed and house dog properly (indoors), maintain inoculations, control dog on harness or leash when in public or off premises of dog's home. The dog's outdoor area will be secure and acceptable provisions will be made for its safety. Buyer agrees to give the dog proper physical and emotional care and welfare. The Buyer must agree to house the dog indoors as its primary housing. If the dog is found to be neglected, abused, or allowed to live in poor health or poor conditions, The Perfect Pup has all rights to repossession of this dog with no refund to the Buyer. The death, injury, or loss of said dog due to theft, carelessness, recklessness, abuse, neglect, heat stroke, or accident will not entitle the Buyer to any compensation from The Perfect Pup.

I HAVE READ AND AGREE TO ABIDE BY THE ABOVE CONTRACT. I UNDERSTAND THAT NO OTHER GUARANTEES ARE MEANT OR IMPLIED OTHER THAN WHAT IS STATED IN THE WRITING OF THIS CONTRACT. I UNDERSTAND AND AGREE THAT THE PERFECT PUP INC. IS NOT RESPONSIBLE FOR ANY EXPENSES INCURRED IN CONNECTION WITH THE PUPPY ONCE THE PUPPY LEAVES THE PREMISES.
